### Promotion period and Bi-Monthly drawing

1. The Promotion Period ("Promotion Period") of the \$300 Bi-Monthly Cash Giveaway

shall be Bi-Monthly and begins on a Saturday at 12:00:00 a.m. United States Pacific Time (PT) and will end on the following Friday at 11:59:59 p.m. (PT) in accordance with the “Table of \$300 Bi-Monthly Cash Giveaway Dates” below.

2. The first Week of the Promotion during which Subscription Members may enter the Promotion starts at midnight, 12:00:00 on Saturday week one in the “Table of \$600 Bi-Monthly Cash Giveaway Dates” below. Mail-In Entries may be mailed in when the Promotion begins. The first Bi-Monthly Drawing will occur each Saturday thereafter for the promotion period and will be announced the following Monday within the application.

## Entry methods

1. **Entries:** Each Entry is based on a KrowdFit Activity consisting of mindfulness minutes logged into the KrowdFit App via your mindfulness app provider.
2. **How to Enter:**
  - a. Each time you perform five (5) minutes of mindfulness through your selected 3rd party approved application and complete 5 minutes of mindfulness, you earn one (1) Activity Entry in the \$600 Bi-Monthly Cash Giveaway.
3. **Mail-In Entry:**
  - a. You can participate in the \$300 Bi-Monthly Cash Giveaway without becoming a Subscription Member or participating in KrowdFit Activities by following the Mail-In Entry instructions set out in the Official Rules of Participation, Entry Methods Rule 3. Although Entries for multiple Promotions are permitted to be included in each postage-stamped outer mailing envelope, only fourteen (14) Mail-In Entry for the \$300 Bi-Monthly Cash Giveaway will be permitted per envelope received on a timely basis. ## Drawing and Odds

1. On each “**Drawing Date**” the Official Computer will randomly select six (6) winners from the pool of Entries for that drawing.
